## Overview

The Emergency Solutions Grants (ESG) Program provides funding to: 1) engage homeless individuals and families living on the street; 2) improve the number and quality of emergency shelters for homeless individuals and families; 3) help operate these shelters; 4) provide essential services to shelter residents; 5) rapidly re-house homeless individuals and families; and 6) prevent families and individuals from becoming homeless.

The purpose of this Notice of Funding Availability (NOFA) is to request applications for the Program Year (PY) 2026, which has a period of performance of July 1, 2026 - June 30, 2027. Eligible entities already providing ESG Program services or similar services within the state of South Carolina are encouraged to apply for funding. **This is a competitive grant requiring 100 percent matching funds.** Requirements and more details of this funding opportunity are contained in this NOFA.

## A. Program Description

The ESG Program is authorized by subtitle B of Title IV of the McKinney-Vento Homeless Assistance Act (42 U.S.C. 11371-11378) as amended by the Homeless Emergency Assistance and Rapid Transition to Housing (HEARTH) Act of 2009. The program authorizes the U.S. Department of Housing and Urban Development (HUD) to make grants to states, metropolitan cities, urban counties and territories. In addition to the statutes identified above, applicable regulations and grant requirements include, but are not limited to, 24 C.F.R. Part 576 – (Emergency Solutions Grants Program), 2 C.F.R. Part 200 – (Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards), grant agreement between OEO and HUD, grant agreement between the South Carolina Office of Economic Opportunity (OEO) and the successful applicant, OEO ESG Handbook, OEO Fiscal Guidance and Procedural Manual, and Technical Memoranda issued by HUD and/or OEO.

OEO is awarded funding under the ESG Program, Assistance Listing No. 14.231 for the State of South Carolina, and serves as the pass-through entity for this grant. The ESG Program is comprised of five components: 1) street outreach, 2) emergency shelter, 3) homelessness prevention, 4) rapid re-housing, and 5) Homeless Management Information System (HMIS).

Street outreach funds may be used for the costs to: provide essential services necessary to reach out to unsheltered homeless people; connect them with emergency shelter, housing and/or critical services; and provide urgent non-facility-based care to unsheltered homeless people who are unwilling or unable to access emergency shelter, housing or an appropriate health facility. Eligible activities include engagement activities, case management, emergency health and mental health services, and transportation.

Under OEO's ESG Program, emergency shelter funds may be used for the costs: to provide essential services to families and individuals in emergency shelters; for operating emergency shelters; and for relocation assistance for people displaced by a project assisted with ESG funds.

Homelessness prevention funds may be used to: provide housing relocation, stabilization services, short-term rent, and/or medium-term rental assistance necessary to prevent an individual or family from moving into an emergency shelter or another place not designed for or ordinarily used as regular sleeping accommodation for human beings.

Rapid re-housing assistance funds may be used to: provide housing relocation, stabilization services, short-term rent and/or medium-term rental assistance necessary to help a homeless individual or family move as quickly as possible into permanent housing and achieve stability in that housing.

HMIS funds may be used to: help pay the costs of contributing to the HMIS designated by the Continuum of Care (COC) for the area including an equitable portion of the costs of purchasing hardware, software licenses or equipment; obtaining technical support; completing data entry and analysis; monitoring and reviewing data quality; training; reporting; and coordinating and integrating the system.

All applicants must refer to 24 C.F.R. Part 576 - Emergency Solutions Grants Program for more detailed information regarding the ESG Program.

## B. Federal Award Information

The period of performance for the ESG 2026 Program Year is July 1, 2026 through June 30, 2027. Private nonprofit organizations are welcome to apply for the ESG Program for PY 2026. Eligible entities who have previously been awarded an ESG Program grant with OEO are also welcome to apply, however, prior participation does not guarantee an award for this program year. All applicants are required to obtain a certification of approval from the unit of general-purpose local government for the geographic area in which those activities will be carried out. In addition, several other certifications are required to be submitted as part of the application to meet eligibility requirements. See Sections C. Eligibility Information and D. Application and Submission Information of this NOFA.

OEO intends to enter into a grant agreement with each successful applicant to provide ESG Program component services throughout the 46 counties of South Carolina. This is a competitive grant requiring 100 percent matching funds. Successful applicants will receive funding through a cost reimbursement payment method.

## C. Eligibility Information

Eligible applicants include all private nonprofit organizations who already provide ESG services or ESG-related services to the homeless and those at risk of becoming homeless. The ESG Program is intended to be a supplemental grant for an entity's program and is not intended to be the sole source of funding for the program. For profit organizations and units of local government are not eligible to apply. An entity who has previously been awarded the ESG Program grant may re-apply. Only one application may be submitted per entity. All applicants must also submit supporting documentation to meet the eligibility requirements listed below. **Failure to provide such required documentation proving eligibility will likely render the applicant ineligible and the applicant may not be considered for the ESG Program for PY 2026.**

The eligibility requirements are as follows:

1. Be a 501(c)(3) organization registered to do business in South Carolina.
2. Obtain certification of approval (Letter of Support) from unit of general-purpose local government (i.e. county or city) for the geographical area in which those activities will be carried out (**emergency shelter only**).
3. Applicant must already be providing ESG services or services to the homeless/at risk of homelessness individuals/families that are similar to that of ESG components.
4. Be registered with the System for Award Management (SAM). Entities must be registered in SAM.gov to qualify for federal awards which are reported to the public through USASpending.GOV. The entity name registered to the UEI on SAM.gov must match the name of the entity on the application. The applicant's SAM registration is required to be maintained, kept active and in good standing until all final reports required are submitted or the final payment is received, whichever is later. Additionally, each applicant must have and maintain a unique entity identifier (UEI), as defined at 2 C.F.R. §25.300. If you have not already registered or your registration has expired, you must register immediately. The General Services Administration (GSA) provides tools that will assist you registering your entity and obtaining a UEI.

5. Have written policies and procedures (fiscal, program, human resources, etc.).
  6. For applicants meeting the \$1,000,000 federal funds expenditure threshold, the applicant must be compliant with 2 C.F.R. §200.512, and a copy of the entity's single audit report must be made available to the public, submitted to the Federal Audit Clearinghouse, and provided with the application. For applicants that do not meet this \$1,000,000 threshold, a copy of the applicant's audited or compiled financial statements must be provided. If the applicant has not had its financial statements audited or compiled by a certified public accountant (CPA), it must certify that it will have its financial statements audited or compiled by a CPA the next fiscal year and provide a copy of the current unaudited financial statements.
  7. Not owe federal debt.
  8. Not be debarred or suspended at the federal or state level.
  9. Provide all required certifications and documents listed at Section D. Application and Submission Information of this NOFA.
  10. Must be an active member or currently pursuing membership in its local COC and participate in the coordinated entry system.
  11. Provide matching contributions equal to 100 percent of the amount awarded should the applicant be successful. Contributions identified as match for the ESG Program must not be used as match for any other grant, program or award. **Failure to identify match contributions equal to the amount requested in the application or submit the required certification for such contributions to be used as match will immediately render the applicant ineligible.** All match contributions must be compliant with 2 C.F.R. §200.306 – Cost sharing and 24 C.F.R. §576.201 – Matching requirement. Examples of allowable match funds include donations of cash, buildings or materials and services contributed by volunteers.

## D. Application and Submission Information

1. OEO has designated the individuals below as the official contacts for purposes of this NOFA. The Official Contact is the Primary Authorized Contact for this NOFA and, as such, handles all related communication on behalf of OEO. OEO has also designated a Secondary Contact as back-up, who may only be contacted when authorized by the primary authorized contact. **Applicants must first contact the Primary Authorized Contact.** Applicants, prospective applicants and other interested parties are advised that any communication with any other OEO employee(s), including appointed officials of OEO, or personnel under contract with OEO about this NOFA is strictly prohibited. Applicants or prospective applicants who violate this instruction risk disqualification from further consideration.

2. The NOFA is available in electronic format on OEO's website at [www.oeo.sc.gov](http://www.oeo.sc.gov) under the Resources and Forms tab. Paper copies of all documents are also available from the Official Contact upon request.
3. The application, including all required certifications and supporting documentations listed in the NOFA, comprise a completed application.
4. Only one completed application may be submitted per eligible entity. A completed application with all required supporting documentation and certifications may be submitted electronically via email to the Official Contact noted above or a hard copy or electronic copy (thumb drive) may be submitted to the Official Contact. All documents submitted as part of the application must include an original signature where applicable. OEO will accept an electronic signature if application is submitted electronically. If any of the required supporting documentation is not compatible with Microsoft Office Word or Microsoft Office Excel, it must be scanned and submitted in Portable Document Format (PDF) or similar file format. An OEO Official Contact will notify the applicant of receipt of the application through a confirmation email.
5. Each applicant is required to be registered in SAM before submitting an application and continue to maintain an active SAM registration, if awarded, until all final reports required are submitted or the final payment is received, whichever is later. Additionally, each applicant must provide and maintain a unique entity identifier as defined at 2 C.F.R. Part 25 Appendix A. The name registered to the unique entity identifier must be used as the applicant's name on the application. **Failure to meet these requirements may result in the applicant being disqualified and deemed ineligible for the ESG Program.**
6. **Documents and certifications that must be included with the application to meet the eligibility determination include all of the following:**
  - a. Single Audit Certification.
  - b. Most recent single audit report, audited financial statements, or compiled financial statements. If the applicant has not had its financial statements audited or compiled, then a copy of the unaudited financial statements must be submitted.
  - c. **Complete** fiscal, program, human resources, code of conduct, conflict of interest written policies and procedures and board by-laws (providing only the table of contents is not sufficient).
  - d. Organizational chart, including any vacancies.
  - e. Board of Directors roster, including any vacancies.
  - f. Federally negotiated indirect cost rate agreement, if applicable.
  - g. Calculation of Modified Total Direct Costs if applicant will charge the de minimis rate.
  - h. Letter of commitment from the Board of Directors.
  - i. Certification of approval (Letter of Support) from unit of general-purpose local government (i.e. county or city) for the geographical area in which the activities will be carried out (**emergency shelter only**).
  - j. Endorsement letter from the applicant's local COC (must be provided directly from COC to OEO).
  - k. IRS Federal 501(c)(3) tax exempt letter to do business in South Carolina.
  - l. Nonprofit registration letter from the South Carolina Secretary of State confirming **active** registration;
  - m. Copies of inspections required by local county/city government in order to operate a shelter. This would apply to any applicant that will use ESG program funds to operate a physical shelter.

Any supporting documentation or certification required to be submitted must be in effect and active throughout the period of performance. If a supporting document or certification is active at the time of application but will expire prior to the issuance of a grant agreement, the successful applicant must provide an updated document and/or certification for continued receipt of funding.

7. Listed below are important dates and deadlines. A deadline includes the date and time by which OEO must receive the application or appeal. Postmarks by the deadline are not acceptable. **Failure to meet the time and date of the deadline will result in the application or appeal neither being reviewed nor considered.** Note that

dates are subject to change based on HUD allocation of FY 2026 ESG grant funding to OEO. OEO may amend the schedule as needed. Any changes will be made by means of an addendum to this NOFA and will be posted on OEO’s web page.

8. Applicants are advised that all materials associated with this NOFA are subject to the terms of the South Carolina Freedom of Information Act (FOIA) (S.C. Code §§30-4-10 et seq.), S.C. Code §30-2-40(B), the Family Privacy Protection Act (S.C. Code §§30-2-10 et seq.) and all rules and regulations. If an applicant deems that certain information required by this NOFA is confidential, the applicant must label such information as “CONFIDENTIAL.” In the last section of the application, the applicant must reference where the information labeled as confidential is located in the application. For each subsection so referenced, the applicant must provide a convincing explanation and rationale sufficient to justify an exemption of the information from release under the FOIA. The explanation and rationale must be stated in terms of the prospective harm to the competitive position of the applicant that would result if the identified information were to be released, and the reasons why the information is legally exempt from release pursuant to S.C. Code Ann. §30-4-40.
9. By signing this application, applicant is affirming it has not had any business relationships within the past three years that pose a conflict of interest, as defined in OEO’s Fiscal Guidance and Procedural Manual, Section 11 Pre-Awards, Conflict of Interest, and in 2 C.F.R. §200.112 and 24 C.F.R. § 576.404. Applicants who have had any business relationship(s) within the past three years that could pose a conflict of interest shall submit a disclosure statement with their application. Successful applicants are required to be in compliance with 2 C.F.R. §200.112 and 24 C.F.R. § 576.404 at time of application and throughout the duration of the grant agreement.
10. OEO will hold a virtual applicant conference on March 11, 2026, from 10:00 AM – 1:00 PM EST, during which potential applicants may ask questions about the application process, program and eligibility requirements, and this NOFA. OEO will give a brief review of the ESG Program and components during this conference. Applicants may find a link to the virtual conference on [www.oeo.sc.gov](http://www.oeo.sc.gov).

## E. Application Review Information

1. It is the intent of OEO to conduct a comprehensive, fair, and impartial evaluation of applications received in response to this NOFA. When evaluating applications, OEO will use the attached score evaluation form shown under item 6 below.
2. An OEO evaluation team will be designated to evaluate applications submitted in response to this NOFA. The contents of all submitted applications, including any confidential information, will be shared with the evaluation team. Only applications found to be responsive and compliant with all instructions and requirements described herein will be reviewed, rated, and scored. Any application that fails to meet the eligibility requirements or significantly deviates from the requirements of this NOFA will be rejected. Attempts by an applicant or representative(s) of an applicant to contact or influence any member of the evaluation team may result in disqualification of the application.
3. To be eligible for evaluation, the application must be received by OEO on or before the due date and time, meet the application format requirements, follow the required application outline, and be complete (including all

required support documentation and certifications). **Failure to follow instructions or satisfy these minimum submission requirements will result in the application being deemed ineligible and the application rejected.**

4. Applications meeting the minimum submission requirements, including eligibility requirements, will be evaluated according to the established criteria. The criteria are the objective standards that the evaluation team will use to evaluate the merits of the applications. Only the criteria listed in item 6 below will be used to evaluate eligible applications.
5. To ensure coverage throughout the State of South Carolina, applicants will first be sorted by the regional Continuum of Care where they are members or pursuing membership and ranked against those applicants falling within that region, which is as follows:
  - SC Upstate Continuum of Care: Abbeville, Anderson, Cherokee, Edgefield, Greenville, Greenwood, Laurens, McCormick, Oconee, Pickens, Saluda, Spartanburg and Union.
  - Total Care for the Homeless Coalition (TCHC): Chesterfield, Clarendon, Darlington, Dillon, Florence, Georgetown, Horry, Kershaw, Lee, Marion, Marlboro, Sumter and Williamsburg.
  - Midlands Area Consortium for the Homeless (MACH): Aiken, Allendale, Bamberg, Barnwell, Calhoun, Chester, Fairfield, Lancaster, Lexington, Newberry, Orangeburg, Richland and York.
  - Lowcountry Continuum of Care: Beaufort, Berkley, Charleston, Colleton, Dorchester, Hampton and Jasper.
6. All applications will be scored based on the criteria below, with the exception of new applicants. New applicants will not be evaluated on prior performance and may receive up to a maximum of 170 points. Current ESG subrecipients applying for the 2026 program year will be evaluated based on prior performance and may receive up to a maximum of 270 points. All applicants' points earned will then be converted to a percentage score (total points earned divided by maximum available points = percentage score), which will then be used to determine the applicant's rank within the COC region.

7. Awards will not be made to an entity who has been suspended or debarred from receiving federal funds. In addition, OEO may refuse to award a grant agreement to any entity who has an outstanding federal debt shown on the SAM system.
8. Upon completing the evaluation process of all eligible applications, the evaluation team will submit the rankings of all applications to the director of OEO. The final selection of a successful applicant is at the discretion of OEO’s director.

## F. Federal Award Administration Information

### Successful Applicants

Successful applicants will be sent a Notice of Intent to Award by email or U.S. mail by May 29, 2026 and offered an opportunity to negotiate a grant agreement with OEO. A Notice of Intent to Award will also be posted on the OEO website. Negotiations may, but will not automatically, result in a grant agreement. A risk assessment of the successful applicant will be performed and will be made part of the negotiations. Additional grant conditions may be placed on the successful applicant depending on the results of the risk assessment.

The Notice of Intent to Award does not authorize the entity to begin performance. Once the grant agreement has been signed by the director of OEO, it will be provided to the successful applicant (via U.S. mail or in person) for approval and accepting signature. Upon complete execution of the grant agreement by OEO (Recipient) and the successful applicant, the successful applicant will become a subrecipient.

All required reports, invoices and other documentation must be sent to the Recipient, in a manner acceptable to the Recipient, to comply with HUD standards for participation data and reporting under the HMIS. “Acceptable to the Recipient” means that the work product is submitted within the required time frame, completed in accordance with generally accepted accounting principles, and is consistent with the approved budget and the grant agreement. Subrecipient also agrees to comply with the Office of Management and Budget requirements for Universal Identifier and Executive Compensation Information at 2 C.F.R. Part 25, Appendix A – Award Term, and 2 C.F.R. Part 170, Appendix A – Award Term.

Successful applicants will be required to submit a Request for Reimbursement (RFR) and Match Report to OEO at least once quarterly and may be submitted as often as monthly. All supporting documentation must be submitted such as invoices, bills, timesheets, cancelled checks, bank statements, etc.

### **Unsuccessful Applicants**

Unsuccessful applicants will be sent a Notice of Denial of Award by email or U.S. mail by May 29, 2026. Unsuccessful applicants will be notified of their right to appeal pursuant to the process provided in the paragraph entitled “Appeals” below.

### **Appeals**

Applicants aggrieved in connection with this award may be entitled to appeal, but only as provided below. To appeal the selection made as a result of this NOFA, applicant must submit to OEO a **written notice of its intent to appeal** on or before June 5, 2026, 5 PM EST and the actual **appeal** on or before June 19, 2026, 5 PM, EST. All notices of intent to appeal and appeals must be in writing, addressed to the OEO contact person listed below, and received within the times provided.

**All actual appeals must include the grounds of the appeal and the relief requested with enough particularity to give notice of the issues to be decided.**

Notices of Intent to Appeal and Appeals that do not meet the requirements of this section will not be considered. Appeal(s) meeting the requirements will be evaluated for merit by the OEO appeals team without the request for additional materials or modifications. Following the appeal review, the OEO appeals team will make a recommendation to the director of OEO, who is the final authority on all appeals. A written notice of the results of the appeal will be sent to the appellant within one week from the date of the decision made by the OEO director. The decision made by the director of OEO shall be final and conclusive.

## G. Other Information

- a. OEO reserves the right to correct inaccurate notices resulting from clerical errors. This may include, in extreme circumstances, revoking the notice of the right to negotiate an award already made to an applicant and subsequently offering the right to negotiate an award to another applicant. Such action on the part of OEO shall not constitute a breach of agreement on the part of OEO since the agreement with the initial applicant is deemed to be void *ab initio* and of no effect as if no contract ever existed between OEO and the applicant.
- b. Unless expressly authorized by OEO in advance in writing, all services hereunder shall be provided by the subrecipient directly and no sub-contract for the provision of such services shall be entered into by the subrecipient. Authorized subcontracts under this grant shall be in writing, attached to this grant and shall be subject to the terms of this grant. The subrecipient shall be responsible for the performances of all subcontracts.
